

ARENA DRIVING TRIAL SCORING

Dressage

1. Add together all the marks given by the judge and enter on the Sub Total line.
2. Multiply the Sub Total by the Factor number and enter the resulting number to two decimal places, on the Factored Points line. (ie. 56.24)
3. Subtract the Factored Points from 150 and enter that amount after the equals sign (=) for the Penalties.
4. Enter any penalties received for errors during the test on the Errors line.
5. Add the Penalties to any Errors received for the Total Penalties for the test.
6. Enter onto the Arena Driving Trial Event Sheet, the total penalties for dressage.

Cones

1. Enter under the Competitor column, the Competitor's numbers for each driver in the class.
2. As the driver goes through each gate of cones, enter into the corresponding box for the numbered gate, a dash (-) if the gate is clear (no balls are dislodged) or a 3 if a ball is down. If the balls on each cone are dislodged, the driver only incurs 3 penalties.
3. If the driver has a disobedience at a gate, record 5 penalties for each occurrence. Indicate this with the letter "D" at the top of the box for the gate. Enter the total disobedience penalties in the Disobedience column to the right of the score sheet. Penalties for cantering (if not allowed in the prize list) are entered in the Disobedience column.
4. In the Course Penalties column to the right of the Disobedience column, enter the total number of penalties for balls down.
5. In the Time On Course column, enter the time the driver took to complete the course, in minutes, seconds and hundredths of a second (ie. 2:34.86)
6. In the Overtime column, enter the amount of time over the Time Allowed that the driver took to complete the course. Enter this time in minutes, seconds and hundredths of a second as well.
7. Convert the time over the time allowed into total seconds and hundredths and multiply by .5 to get the total time penalties (ie. 0:42.16 becomes 21.08 time penalties) and enter the resulting amount in the Time Penalties column.
8. Add together all the penalties from the Disobedience, Course Penalties, and Time Penalties columns and enter into the Total Penalties column.

9. Transfer onto the Arena Driving Trial Event Sheet, the Course Penalties (the 'C' column) and the Time Penalties (the 'T' column) and add together to get the total penalties for the Cones competition.

Marathon

1. On the Arena Driving Trial Event Score Sheet, enter the time taken for the first round of the marathon in the #1 column, in minutes, seconds and hundredths of a second. Do the same for the second round of the marathon and enter in the #2 column.
2. Convert the time in each column into seconds and hundredths (ie. 2:37.67 becomes 157.67) and add together. Enter this number into the Total Time column.
3. Multiply the total time by .2 to arrive at the Total Time Penalties and enter that amount into the Total Time Penalties column.
4. In the O/P column, enter and Other Penalties the driver received during the marathon.
5. Add together the Total Time Penalties and Other Penalties to get the Total Penalties for the Marathon and enter into the Total Penalties column.

Final Placings

1. Add together the total penalties from Dressage, Cones and Marathon.
2. Enter this amount into the Event Total column.
3. Placings are given in reverse order. The lowest number of penalties is placed first and so forth.
