SPECIAL BULLETIN

As the proud insurance partner of HCBC, we wanted to remind all members in good standing of some important elements of insurance coverage that are provided AUTOMATICALLY through your membership;

- 1) All members are provided \$5,000,000 of personal liability insurance which covers any number of horses owned or leased for personal use.
 - For those members who own horses that have been displaced due to the widespread fires (or threat of fire) in the Province, this coverage follows you anywhere.
- 2) As an included extension, the liability insurance covers the temporary and non-commercial CARE, CUSTODY and CONTROL of NON-OWNED horses.
 - This coverage will be particularly important to those in the community that have agreed to temporarily house horses they do not own while the fire threat remains high.
- 3) For those members who have insurance in force covering their horse under our **Equi-Care** mortality insurance policy, there is an automatic extension providing reimbursement for short term stabling **extra expense**.
 - This coverage is triggered when the usual stabling where the horse normally lives, becomes un-tenantable due to fire or threat of fire (evacuation ordered)
