





2023 COACH STATUS PROGRAM SPECIFICATIONS

Effective January 1st, 2023, Licensed Coach Status is mandatory at all EC sanctioned <u>Gold</u> and <u>Platinum</u> events. Registered Coach Status is mandatory at all EC sanctioned <u>Bronze</u> and <u>Silver</u> events; Licensed Coach Status also accepted.

Coach Status Program Requirement Deadline

Initial Application: 90-day

Renewal Application: 60-day prior to Coach Status expiry date

*Coach Status renewed after the current term's expiry date will result in **Coach Status interruption**.

SCREENING REQUIREMENTS
☐ Equestrian Canada Online Screening Disclosure Form via the ECampus
*In the last 10 years, if you have lived outside of Canada for more than 6 consecutive months, international screening is required. An initial processing fee of \$100 will apply which includes one (1) country. A \$50 fee will apply for each additional country declared.
**Please note, legislation in certain countries may require the candidate to obtain a police certificate or a certificate of good conduct from the appropriate authorities within the country (ies) of residence. Additional costs are incurred by the candidate. Sterling will be initiated by EC once the certificates have been submitted.
□ Canadian Criminal Record Check (CCRC)/Enhanced Police Information Check (EPIC)
*No additional charge if completed via Sterling BackCheck
NEW REQUIREMENT 2023 : A Level 2 verification (EPIC or equivalent) is required. Must include results from the RCMP National Repository database and includes Local Indices.
**CCRC/EPIC and international screening are not required if you are under 18 years of age. Must submit two (2) Letter of Reference Forms in lieu.
□ Vulnerable Sector Search (VSS) OR Vulnerable Sector Search Acknowledgment (VSSA) Online Form
*Date of birth will determine which requirement is to be completed. If you are born on March 12th, 1994, or before, a VSS is required. If you are born after March 12th, 1994, the VSSA must be completed.
□ Two (2) Equestrian Canada Letter of Reference Form

□ EC Certificate of Insurance

Minimum Required Coverages:

- \$2,000,000 Commercial General Liability
- o \$100,000 Professional Liability Insurance
- o Equestrian Canada (EC) and your Provincial/Territorial Equestrian Association (PTSO) must be named as additional insured **AND**
- o Waiver of subrogation in favor of EC and your PTSO

□ Waiver of Insurance and Acknowledgment of Risks Form

*Applicable if you are insured/employed by a facility. An EC Certificate of Insurance is required from the applicable party.

- ☐ \$199.95 Licensed Coach Status Fee & Enrollment via MyEC
 - *EC/NCCP certified coaches receive a 15% discount (\$169.95)
 - **Mid-Term Upgrade Fee: Non-NCCP Certified \$150 NCCP Certified \$120
- ☐ Complete Safe Sport, Screening and Insurance requirements as described above
- ☐ COACH CERTIFICATION/VERIFIED EXPERTISE (1 of 4)

Candidates must have recognized credentials in one (1) of the following categories:

- 1. National Coaching Certification Program (NCCP)
- 2. EC Recognized Non-NCCP Certification
- 3. Post Secondary Education
- 4. Certification Exemption Request (CER): outlines a candidate's coaching abilities and qualifications based on experience, knowledge and training acquired through alternative mean. The CER is a subsequent application within the Licensed Coach Status program.
 - *Coaches must have a minimum of **15 years** experience in a leadership capacity.
 - **Two (2) Equestrian Canada Letter of Reference forms required to support a CER application.
 - ***A non-refundable \$200 fee applies. One-time fee for successful candidates.

<u>Please note</u>, professional development is required for category **two (2)**, **three (3)**, and **four (4)**. Must complete NCCP Make Ethical Decision (MED) <u>AND</u> NCCP Make Ethical Decision, Online Evaluation
