Grant intake period – March 15, 2025, until funds are depleted.

HCBC, with financial assistance from Acera Insurance, is pleased to announce a new grant for HCBC members who are Instructors or Coaches and are working to pursue the next level of certification on their coaching pathway.

Grant goals: To provide financial assistance to Coaches and Instructors progressing towards a higher Certification in English, Western or Drive disciplines. This grant will encourage coaches to upgrade or further their certification by removing a portion of the cost of certification.

Example:

• Currently an instructor moving to Coach Certification

Successful applicants will receive a Grant of \$500.00 towards the fee's associated with applying for and participating in a Coaching Evaluation. The evaluation can be in person, by video or through a Cohort. Funds can also be used to pay for travel to an in-person evaluation.

- Be a current HCBC member and reside in BC
- Have completed Concussion Training (attach proof)
